Overview

Responsibilities

The Survival, Evasion, Resistance and Escape (SERE) Academic Training Instructor will support the Naval Special Warfare Advanced Training Command (NSWATC) provide advanced training to Naval Special Warfare trainees and other select groups.

This effort includes full professional, technical, logistic, and curriculum service support for four (4) different courses of instruction related to SERE and Personnel Recovery (PR). The courses are taught to both Navy SEAL/Special Warfare Combatant-craft Crewman pipeline students and Combat Support/Combat Service Support (CS/CSS) personnel.

Specific duties include:

- Apply direct knowledge of SERE based training to influence training technique and structure
- Display high personal standards of technical knowledge and professional competence in delivering training material
- Perform in a military environment
- Use technology available during instruction
- Produce and update training materials, as required
- Deliver lecture type setting teaching to students
- Potentially handle classified material, publications (DoD SERE and Personal Recovery) and possess knowledge to access required documentation
- The length of the duty day shall vary depending on the scheduled training
 - Shift work may be necessary to support training requirements

Qualifications

Required:

- **Current DoD Active SECRET clearance**

Experience/Education

- At a minimum, must be Ex-military with a rank of E-4 or higher
- Must have a minimum of four (4) years of honorable service in the U.S. military
- Must have prior experience as a military instructor
- Must have successfully complete an approved DoD Instructor Training Course (ITC), or other



equivalent.

- *Preferred* to have a Master Training Specialist designation
 - Instructors not currently possessing the Master Training Specialist designation shall work toward attaining the MTS qualification within the first eighteen (18) months of hire as an instructor
- Must be able to update curriculum, evaluate training, read student critics, conduct administrative tasks relevant to the SERE program or COI's, and work on professional development or skills necessary to complete COI's during non-active training periods.
- Instructors shall have graduated and have qualified as an instructor of an approved DoD SERE Level "C" Course to include:
 - Completion of an accredited SERE training program such as the SERE Instructor Naval Enlisted Classification (NEC)
 - SERE Military Occupational Specialty (MOS)
 - SERE Air Force Specialty Code (AFSC)
 - The qualified SERE instructor requirement can be waived for former SEALs, SWCCs who have previously qualified as a high-risk instructor
- Must be able to successfully complete medical (OPNAVINST 1500.75B) and psychological screenings.
- Must have passed a physical examination within the past 12 months administered by a medical doctor.
- Must be a U.S. Citizen
- Must have a valid state drivers license

Preferred Requirements:

- *Preferred* to be familiar with military with organization and hierarchy of the US Navy / military rank structure
- *Preferred* to have, direct experience as a current or previously qualified DoD SERE Instructor at a Joint Personnel Recovery Agency (JPRA) certified Level "C" Code of Conduct School Specialized Experience.
- *Preferred* to have experience as a Navy NEC 9518 (Naval Leadership Development Program (NAVLEAD) Instructor, or Graduate of one of the following courses of instruction:
 - Instructional Delivery Continuum (IDC) Journeyman Instructor Training (JIT) (A-012-0077)
 - Instructional Delivery Continuum (IDC) Journeyman Instructor Training (JIT) Mobile Training Team (A-012-1011)
 - Naval Leadership Facilitator (P-012-0045)
 - Facilitator Training Course (P-012-0075)
 - Nuclear Instruction Qualifications (NFAS) (A-661-0108)
 - Nuclear Instruction Qualifications (NNPS) (A-661-0109)
 - Other DoD Service designation (or equivalency) upon approval of the CENSECFOR DOT (See Note below), or
 - Completion of a civilian (or commercial) formal course of instruction which has been evaluated and certified as a JIT equivalency by the Center for Personal and Professional Development (CPPD)
- Preferred to be qualified and familiar with all role-play and live fire weapons used in the performance of their duties in accordance with NSWC policies and procedures
- Preferred to possess the skill and expertise in weapons handling.



Physical Demands
