- Experience in security training or security inspections is highly desirable.
- The position requires solid and varied experience in planning/accrediting facilities in accordance with the ICD 7051 standard.
- Thorough familiarity with all security processes.
- Must have a working knowledge of security policies and procedures to include National Industrial Security Program Supplement, and DoD 5105.21 volumes 1-3 and DODM 5200.01 V1-V4.
