This includes the responsibility for formulating, guiding, and directing the technical approach; and defining and negotiation with activity and agency personnel for necessary resources. Establishment and control of technical milestones, schedules, budgets and costs are also essential tasks.

- Bachelor's degree from an accredited college or university
- 10 or more years of qualifying experience

Desired Qualifications

- Master of Science degree in a recognized engineering, scientific, mathematics, or technical discipline from an accredited college or university
- 15 or more years of qualifying experience
- Qualifying experience should be in directing progressively complex programs and systems of a technical nature with at least half of the years of experience in directing efforts involving management and/or supervision of technical and administrative personnel to complete tasks relating to the design, development, integration and delivery of complex systems for program areas such as Counter Radio Electronic Warfare (CREW), Joint Explosive Ordnance Disposal (JEOD), Underwater Explosive Ordnance Disposal (UWEOD), Expeditionary Medical (ExMed), and Anti-Terrorism Afloat (ATA).
